Since new risks could arise between the preparation of this report and the event taking place, an MSP member of staff will be assigned to review the risk assessment immediately before the event starting and to monitor any additional risks asising throughout it.

Should new risks be identified by the event organiser, MSP or SGO staff they should be recorded below, by the asigned member of the MSP team along with corresponding control measures 'multiplied by the 'Impact beyond control measures' rates 9 or above the event should be halted. The risk should then immedately be reviewed by the School Games Organiser lead for the event and a manager from MSP to establish if any further controls can be put in place which may allow the event to continue as planned.
