Subject: Governance Code - External Board Evaluation update

Dear CSP Director,

We are aware that there are a number of queries being raised across the Network in regard to point 4.2 of the Code for Sports Governance - External Board Evaluation.

We can now confirm that in collaboration with CSPN we will be seeking to provide an External Board Evaluation offer open to all CSPs. We intend to procure one or more providers who will be able to offer the evaluation. The benefits will be the economies of scale due the potential number of CSPs involved and a more standard approach to the evaluation for the Network. In terms of the product we are looking to build an evaluation package which would of course meet the standards required for the Code as well as supporting the improvement of the priority areas of your organisation.

We recognise that there are significant costs to the evaluations, so as well as the economies of scale which this offer will bring, we are also investigating other financial support which may be available to support this. Initially we are looking for all CSPs to carry out an evaluation within the 4 year window (from implementation of the Code) and the timing will be considered in line with the needs of your organisation. We would look for this to be phased so not all CSPs would be evaluated in the same year.

We would encourage all CSPs to support this offer, however if you do wish to continue with another provider then this will still be acceptable presuming that the evaluation meets the standards outlined in the Code. Please confirm by reply to this email if you wish to be considered in this process. Our next steps will be to agree which CSPs are included in the first wave of evaluations and the timescales for completion of all.

If you are yet to recruit and finalise on an external board evaluation then you may want to pause on this process until we have appointed and are able to confirm the chosen supplier(s). Please be assured that if you want to take this opportunity to be part of the Network wide offer, then you will remain compliant for this element of the Code for Sports Governance. We will then work with you directly to agree new timescales on point 4.2.
